And that is reasonably relied upon by the others(s) who were injured thereby.

**Fraudulent Concealment** is the intentional failure to disclose a material existing fact, and especially the existence of a Cause of Action. By one under a duty to make such a disclosure to another who acts or fails to act in reliance and suffers a loss.
